Miller Amusements, the Carnival company with whom we have contracted, has exclusive rights on the following products: *popcorn, sno-cones, candy apples, and cotton candy*. The Hillsborough Fire Department has exclusive rights on *hamburgers*. Angelino's has exclusive rights on *sausage*. Carolyn Dudley has exclusive rights on ice cream. As such no other vendor is allowed to sell these items.

All vendors will be considered on a first paid, first reserved basis. A \$50 non-refundable deposit is required with the application. If your application is not approved, the deposit will be returned. Full payment for space is required by June 30, 2008 to guarantee inclusion.

Pure Crafters - \$17 per frontage foot (10 foot minimum); **Crafters** - \$20 per frontage foot (10 foot minimum); **Food** - \$28 per frontage foot (15 foot minimum). All spaces have a 20' depth.

Vendor Requirements:

- Copy of valid liability insurance certificate required prior to set-up
- Electrical cords/water hoses to outlets are Vendor's responsibility
- 2008 NH Rooms & Meals Tax Number (food vendors only)
- Fire Extinguishers (per fire codes)
- Electrical: 30 amp. Service Required NEMA # L14-30P; 50 amp - 4 Wire Range Plug 15-50P (additional fee of \$10 per day for 50 amp service.)
- Trash disposal in provided dumpsters
- Vendor must clean up space at close of event
- Sale or consumption of alcoholic beverages is not allowed on Grimes Field
- Overnight security patrols by Hillsborough Police Dept.
- Tobacco sales are not allowed on Grimes Field
- Sale or possession of firearms or any kind of weapon is not permitted on Grimes Field
- Access to field by Vendor Parking Permit only - field parking is limited to essential vehicles
- R/V parking at field (no hookups) additional charge of \$50 required
- Use of Hillsborough Balloon Festival and Fair logo or name is not allowed on any products ie: t-shirts, polo shirts, caps or hats, coffee mugs etc. without written permission from the Hillsborough Civic Organization. The sale or display of any device, toy, game or products deemed by the Vendor Coordinator to be destructive, offensive, harmful or hazardous to property or persons will not be permitted on Grimes Field.
